A BILL FOR AN ACT

101 CONCERNING THE PENALTIES IMPOSED ON THE DRIVER OF A MOTOR
102 VEHICLE WHO CAUSES AT LEAST SERIOUS PHYSICAL INJURIES TO

A VULNERABLE ROAD USER.

## **Bill Summary**

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Current law prohibits driving a motor vehicle in a careless manner. The bill makes it a class 1 misdemeanor when this behavior injures or kills a vulnerable road user; requires a violator to attend a driver improvement school and perform community service; and subjects a violator to a restitution order and license suspension.

1	Be it enacted by the General Assembly of the State of Colorado:
