10:00 AM - Travis Belden - Sheriff - Updates

Sheriff Belden reported on the recent pursuit chases last weekend with one resulting in a stop spike being used. A quote was brought in to replace the stop spikes. Operation Plan for the Wildfire changes are suggested on page 4 on who requests for plane support; whoever makes the request is responsible for payment.

10:30 AM - Heather Morris - EMS Director - Purchase Orders and Staff

Ambulance Director Morris presented a quote from Stryker for replacing cables and one for Titan III Wi-Fi Gateway that would allow electronic medical information to be gathered from the life packs that would save transferring patient information and improve billing. These will be requested for 2022 Budget. An application for the full time position that would be a full time driver and expected to complete the EMT course in six months was presented for review.
