BOARD OF PUBLIC HEALTH:

BOARD OF DEPARTMENT OF HUMAN SERVICES:

The Department Head Meeting was hosted by the Extension Agent Scott Stinnett, at 8:35 AM. The Pledge of Allegiance was recited. Those present were Scott Stinnett, Collin Koop, Travis Belden, Randy Gorton, Shawn Franz, Della Calhoon, Ashley Hernandez, Heather Morris, Valerie Boyd, Kristi Janousek, Susan Corliss, Dave Hornung, and Stan Hitchcock.

DEPARTMENT HEADS MEETING

Collin Koop - Grounds & Buildings - indicated that a new hire starts tomorrow. They are working on show barn and happy they have completed the county's work that was due to be done by February 1st. There is an AC/Heat unit down for the 3rd floor and half of the Clerk and Recorder's office. The parts are ordered but not here yet. The courts have been able to continue with space heaters. They are wrapping up the odds and ends for the end of year. Cleaning in the Annex basement has removed dump trunk worth of trash. They are planning to clean the 2nd floor of the Ambulance Shed after the 1st of the year.

Travis Belden – Sheriff – stated they continue to be very busy not a shortage of crime. The department is short one on patrol. There was a little concern since a deputy has been in the schools a lot; this is just to have a positive influence with the youth and police.

Randy Gorton – Coroner/Landfill – reported that the Landfill is fighting the dusty conditions by watering down a lot. The need to move to new cell; the old cell is not required to be closed but will be covered. The State audit has not been scheduled. As Coroner, it has just been busy.

Shawn Franz – Dispatch – shared that he is working on merger with Cheyenne County with a projected transition on January 17, 2022. CenturyLink is the one link that needs to be finalized on their timeline.

Della Calhoon – OEM – received recognition from the Board of County Commissioners on her 47 years of service and upcoming retirement.

Ashley Hernandez – OEM – stated that she is busy with training. Kit Carson County will be hosting the ICS 300 & 400 Training that are each a 2 day class which will be in March or April. State wants us to do CEPA; a self-grading training. She is looking into ways to email required information



so that the department heads could work on their own pace. There will be a meeting scheduled for June 7th for this training.

Heather Morris – Ambulance – reported that they received the DEA license and are working out details for getting ALS medications. Continue to be short staffed due to being down one full time employee, one out for paternity leave/time off, one with daycare issues. Staff are putting in overtime due to all of the above reasons. Doing their best to cover Stratton as much as possible between three people when not covering in Burlington. Multiple staff are continuing education which will better the coverage and transfer capabilities for the county. Finishing up rig checks to ensure they are ready for the recertification survey on December 17th. Repairs are needed to the ceiling and walls in the Burlington shed and garage door needs repairs in Stratton. KC10 doors do not open or close from inside the rig in Stratton. One of the two paramedics is in house today and finishing up his orientation.

Valerie Boyd – Public Health – stated they are staying busy with vaccinations. Child care center project is trying to bring that to the community. Cleaning basement is going well. Public Health of the Rockies was their conference in August instead of partnering with CCI.

Kristi Janousek – Human Services – shared the dates that Director Tiffany Ramos will be out during December. She will be in charge with Karly Lane covering Child Welfare. At the CCI Conference, Tiffany Ramos was named Department Human Services' Director of the Year. The staff is working on wrapping TANF gifts that parents will be able to pick up next week. Eligibility is fully staffed. Baby bear hugs is now available for Kit Carson County families; advertising will start soon to contact Tiffany.

Stan Hitchcock – **Commissioner District 1** – stated that Road & Bridge District 1 is doing maintenance as the main project while several staff are using up comp and vacation time. He shared that Cory Wall has interviewed for open position in Road & Bridge District 2. Lynsay Cormack is currently out as well.

Dave Hornung – Commissioner District 3 – indicated that the Mill Levy certification is next week and the budget will be finalized. The plan is to review it today. They are searching for an auditor. Road & Bridge District 3 has replaced a bridge with culverts on County Road 1. The staff is also using comp time and vacation time, unless there is a blizzard.

Susan Corliss – Clerk and Recorder – stated that emails have been going out to the Department Heads to begin the updating of the 2022 Reorganization resolutions. The

Department Head host schedule was passed out for 2022. The Coordinated Election was certified on November 18th; across the state the mandatory recounts have been matching the final elections with only having a one or two vote variance due to judge adjudication. A new agenda and minutes management program will be starting in early January.

Scott Stinnett – Extension – reported that it is re-enrollment time but most of them will come at the deadline of January 15th. a new director was hired at the end of 2019, now changes are coming from the top down. CSU is doing some rural outreach outside of the Extension Service. McKayla has been working on Safe Serve programs. Ron is working on year end reports and will be doing speaking engagements during the winter months. The Extension Office is fully staffed.

The Kit Carson County Department Head Meeting adjourned at 9:20 AM.

Next meeting is Tuesday, January 11, 2022, with Commissioner Cory Wall as host.

The Board of County Commissioners meeting convened at 10:00 AM. Those present were Dave Hornung, Stan Hitchcock, and Susan Corliss. Commissioner Cory Wall was excused.

DATA COLLECTION & ROAD ASSESSMENTS

Dallin Stott gave a presentation on iWorQ for the roads in the county.

The Board of County Commissioners meeting recessed at 10:28 AM.

BOARD OF PUBLIC HEALTH

Stan Hitchcock moved to go into the Board of Public Health meeting at 10:30 AM, seconded by Dave Hornung. The motion carried. Those present were Stan Hitchcock, Dave Hornung, Valerie Boyd, and Susan Corliss.

Valerie Boyd shared an update on the NFP program. The mandate for vaccination will possibly affect the Nurse Family Partnership program. If there is a loss of three nursing positions, Kit Carson County may withdraw from the program. Valerie will explore with the partner counties the impact if Kit Carson County would withdraw as the fiscal agent of the program.

There is a Public Health Order to make the Monoclonal Antibodies treatment easily available across the state. The hospital is only able to offer a limited number of treatments. Kit Carson County Public Health & Environment would like to host a travel treatment bus for two weeks at the fairgrounds parking lot to offer treatments to the community.

Stan Hitchcock moved to adjourn the Board of Public Health meeting at 11:02 AM, seconded by Dave Hornung. The motion carried.

The Board of County Commissioners meeting reconvened at 11:03 AM.

VICTIM ADVOCATE - VALE GRANT APPROVAL

Lisa Belden, Victims Advocate Director, presented a request for the 2022 Victim Assistance & Law Enforcement (VALE) Fund. Lisa presented the 2022 VALE Grant Award for approval for January – December 2022. The budget for the grant needs to be adjusted because the award is \$2,000 less than was requested in application.

Stan Hitchcock moved to sign the 2022 VALE Grant Award budget of \$6,500.00 for personnel and supplies & operating expenses, seconded by Dave Hornung. The motion carried.

The Board of County Commissioners meeting recessed at 12:00 PM for lunch.

The Board of County Commissioners continued in work session at 1:00 PM. Those present were Dave Hornung, Stan Hitchcock, Travis Belden, and Susan Corliss.

DISTRICT ATTORNEY

The Board of County Commissioners had a discussion on the phone with the 13th Judicial District Attorney, Travis Sides, about the 2022 Budget along with some other concerns.
