At 8:00 AM on Tuesday, January 12, 2021, Judge Michael Grinnan swore in Commissioner District 1 – Stan Hitchcock and Commissioner District 3 – Dave Hornung.

The Department Head Meeting was hosted by Commissioner Dave Hornung, as it continued with the Department Head reports at 9:15 AM. Those present were Collin Koop, Della Calhoon, Korena Laue, Randy Gorton, Terry Hubbell, Tiffany Ramos, Dawn James, Scott Stinnett, Jeff Cure, Paula Weeks, Abbey Mullis, Susan Corliss, Cory Wall, Dave Hornung, and Stan Hitchcock. The Department Head reports followed the review and resolutions of the 2021 Reorganization.

# **DEPARTMENT HEADS MEETING**

**Collin Koop – Grounds & Buildings** – shared that they made it through the holidays and now to business as usual.

**Della Calhoon** – **OEM** – nothing to report today.

Tom Ridnour – Sheriff – nothing to report today.

Korena Laue – Ambulance – nothing to report today.

**Randy Gorton – Landfill / Coroner –** shared that the landfill got a new 816K compactor. **Terry Hubbell – Weed District –** nothing to report today.

**Tiffany Ramos – Department of Human Services Director –** nothing to report today.

**Dawn James – Public Health & Environment Director** – shared that by the end of the week 300 doses of the COVID vaccine will have been administered. There will be mass vaccine clinics on the 20<sup>th</sup> and 25<sup>th</sup>, which should bring the total administered 600 doses. Walgreens administered the Pfizer vaccine to the long term care, while Kit Carson County Public Health has covered the assisted living in Burlington, Stratton, and Flagler.

**Scott Stinnett – Extension** – reported that it is a new year and new region. The county is now part in the Northeast Region under that same leadership. There was a County Council meeting last night. The club leaders indicated that the enrollment is looking very similar to last year. There is hope that there could in person activities again at least on a limited basis.

Jeff Cure – Attorney – nothing to report today.

**Paula Weeks – Admin** – reviewed policies changes that will be made in the Personnel Policies as follows: Employees are to take a break of 10 minutes per 4 hours worked, overtime is exempt for Government – it is figured as comp time instead; Paid Leave for COVID19 expired on December 31, 2020, Paid leave for emergency leave like COVID must use earned sick leave before emergency paid leave is used; Part-time employees will earn 1 hour per 30 hours worked up to 48 hours per year but it does not apply to the Ambulance Reserves; Political endorsements will not be allow posters in the workplaces; and EAP - Employee Assistance Plan will include Ryon Medical at Schaal Physical Therapy which will be covered by our insurance if employees need counseling. There was some discussion on whether part-time sick leave would be allowed as carryover to a new year. It was agreed that 16 hours of carryover would help if someone needed it early in the year, noting that there would still be the 48 hours maximum for the next year.

**Abbey Mullis** – **Assessor** – stated that tax bills have went out which means that they are answering many complaint calls.

**Susan Corliss – Clerk and Recorder** – stated that it is business as usual but on the busy side.

**Cory Wall – Commissioner District 2** – stated that Road and Bridge District 2 is fully staffed and business as usual.

**Dave Hornung – Commissioner District 3** – indicated Road and Bridge District 3 is business as usual. Department Heads should be working on their items for the Strategic Plan that will be on the agenda for February or March.

**Stan Hitchcock** – **Commissioner District 1** – shared that there will be a new hire for Road & Bridge District 1. They have been working on replacing a bridge with culverts in the northeast corner of the county.

The Kit Carson County Department Head Meeting adjourned at 9:35 AM.

Next meeting is Wednesday, February 10, 2021, with Clerk & Recorder Susan Corliss as the host.

There was a public reception for the new and re-elected commissioners in the Kit Carson County Courthouse lobby from 10:00 - 11:00 AM. The Board of County Commissioners presented Gary Pautler with a plaque in honor of his 33 years of service on the Kit Carson County Planning Commission Board. Jeff Cure, Kelly Alvarez, and Patty Witzel have worked with him and were present to congratulate him.

# KEN BUCK'S OFFICE – UPDATES AS WE START A NEW YEAR

Darlene Carpio gave an update on activities for Representative Ken Buck including a letter that has been sent to President-Elect Biden to call off the Letter of Impeachment because there needs to be a beginning to unify the country again; this would just continue and further the division. He will be reintroducing the Water Act for mutual water storage. Discussion was held on the need for reliable broadband Internet.
