## **GROUNDS AND BUILDINGS UPDATE**

Collin Koop and Ruben Rodriguez stated that the trenching has been completed for the water project and the transformer update at the fairgrounds. There has been an issue with the food distribution that use the church booths; the cleanup is being left to the Grounds & Buildings. A padded cell for intake is being installed in the Jail. The carpet upgrade will start on Friday at the Annex. McCormick Excavation & Paving presented bids for parking lot repairs:

Annex – Crack Patch w/Grid Reinforcement - \$14,308.15 or Crack Sealant only - \$14,072.50 Employee parking lot at the courthouse – asphalt patching & crack sealant - \$6,077.00.

The Board of County Commissioners are willing to try the machine from Asphalt Kingdom in the amount of \$3,548.00 that was presented last week; that will allow Grounds & Building to patch as needed.

## COUNTY ASSESSOR – HIRING FOR OPEN POSITION

Abbey Mullis shared that there will be a retirement party for Peggy Weibel on Wednesday, April 28<sup>th</sup>, from 9:00 AM to Noon. She requested to begin advertisement for a new employee. They have conducted 775 property inspections that have found many new buildings.

The Board of County Commissioners approved advertising. All county employees will receive an email about the opening per new employment requirements.

## **COUNTY ATTORNEY**

David Churchwell, KC Electric General Manager, presented information about a solar farm and requested land use information. Jeff Cure led the discussion on the land use set back requirements. The Board of County Commissioners expressed that they will be willing to work with KC Electric on this project when it goes to the Planning Commission later this year.

### OPPOSING BALLOT INITIATIVE 16 IN ORDER TO PROTECT OUR LIVESTOCK INDUSTRY AND PREVENT NEEDLESS ANIMAL SUFFERING

WHEREAS, on March 17, 2021, a citizens initiative entitled "Protect Animals from Unnecessary Suffering and Exploitation (PAUSE) was approved by the Title Board of the Colorado Secretary of State for petition to the November 2022 General Election as Initiative 16; and

WHEREAS, the initiative would broadly redefine animal sexual abuse in a manner that would criminalize many common and necessary veterinary and animal husbandry practices: and

WHEREAS, the initiative would additionally require tremendous delays, in some cases years, prior to the humane slaughter of livestock for food; and

WHEREAS, these delays (of up to one-quarter of an animals statutorily defined lifespan) would greatly increase the costs to ranchers to feed and care for these animals which at slaughter would produce meat of low value to the consumer at much higher purchase costs; and

WHEREAS, for many meat producing animal varieties (specifically poultry) bred for rapid weight gain, the result of delayed slaughter will be the suffering of morbidly obese animals unable to support their own body weight for years prior to processing; and

WHEREAS, it has been reported that even the Governor of Colorado agrees that the PAUSE initiative would "hurt Colorado, and destroy jobs"; and

WHEREAS, this board abhors the infliction of needless suffering of animals recognizes that our cattle and livestock producers take great effort to treat their animals humanely.

THEREFORE, BE IT RESOLVED, THAT THE BOARD OF COUNTY COMMISSIONERS OF KIT CARSON COUNTY, COLORADO opposes this Initiative and urges the Governor of Colorado and Commissioner of the Colorado Department of Agriculture to continue to do the same; and

BE IT FURTHER RESOLVED, urges all citizens of Kit Carson County to decline to sign any petition that supports placing Initiative 16 (PAUSE) on the November 2022 ballot; and

FINALLY, SHALL IT BE RESOLVED, that all people that care about the well-being of animals – be they livestock, pets, service animals, or other – take action to defeat this measure if it does make the November 2022 ballot.

#### RE: Opposition to Ballot Initiative 16 (PAUSE)

Dear Governor Polis,

As the Board of County Commissioners of Kit Carson County, a traditionally agricultural county with a large percentage of our citizens employed directly or indirectly in livestock production, processing, or sales, we urge you to continue to publicly oppose the enclosed Ballot Initiative 16, titled "Protect Animals from Unnecessary Suffering and Exploitation (PAUSE)." We further request that the Department of Agriculture be directed to act in concert with the professional organizations representing our livestock producers in their efforts to fight this deceptive initiative.

Though approved by the Secretary of State's Title Board for signature collection, this initiative's title is misleading. The actual text of the measure will strike a killing blow to our great state's livestock industry, the provision of veterinary training, and care for all animals. It seeks to redefine sexual abuse of animals in such a way that many accepted veterinary and animal husbandry practices will be criminalized. The result will be unnecessary suffering of livestock animals, beloved pets, and essential service animals.

Additional requirements in the proposed measure regarding great delays prior to humane slaughter will make ranching uneconomical and produce meat of exceedingly low value to consumers. The gains made in export of these products will be lost. The quintessential Colorado ranches that define us will be lost. Our meat packing industry will be dealt a crippling blow. For a state already suffering economically, the proposal will stall any hope of recovery in our rural areas and increase food costs for all Coloradans.

We fully support protecting all animals from abuse and unnecessary suffering. As do all reputable ranchers and livestock processors. Certainly, our veterinary community does. As well as all Colorado citizens, regardless of their dietary choices, whether they be engaged in agriculture, or are simply caring pet owners. The sweeping changes this initiative envisions are more likely to harm both animals and people than they are to protect them.

It has been reported that you agree "with farmers and ranchers that the PAUSE ballot initiative would hurt Colorado and destroy jobs" and insist on behalf of the citizens of Kit Carson County that you act with all the tools at your disposal as Governor to counter this wrongheaded effort. Do not let the good citizens of Colorado be misled by a catchy title.
