The Department Head Meeting was hosted by the Collin Koop, at 8:33 AM. Those present were Collin Koop, Della Calhoon, Shawn Franz, Randy Gorton, Travis Belden, Heather Morris, Abbey Mullis, Valerie Boyd, Kristi Janousek, Lynsay Cormack, Susan Corliss, Cory Wall, Dave Hornung, and Stan Hitchcock.

DEPARTMENT HEADS MEETING

Collin Koop – Grounds & Buildings – shared that it has been approved to build a new show building at the fairgrounds. They have Installed French doors in the Treasurer's office. They are starting to winterize. Email or call him if you have any needs.

Della Calhoon – **OEM** – reported that she is trying to get caught up of filing and preparing for when Ashley Hernandez starts on November 1st. A reminder that starting October 24th it will be required to dial the 719 for local calls. All ten digits will be required starting that date. Cory Stark asked for everyone to bring their laptop to the November Department Heads meeting for the exercise he will be presenting.

Shawn Franz – Dispatch – shared that on September 19th the battery backup went out in the Communication Center, that required replacement. Collin & Ruben did a one day round trip to Minneapolis to get a new one so that Daniel Electric could install it. KC Electric had an outage recently and the Bethune generator did not come on; the state will be here to fix it today at 10:00. The telephone outage in Burlington had 911 calls being rerouted to Teller County; com center has lines set up to monitor the rollovers. Local landline calls were restored before the outage was repaired. Dispatch will now have the same medical advisor as the Ambulance Department; this has been requested for a long time to improve what the dispatch can do during 911 calls.

Randy Gorton – Coroner/Landfill – stated that the wind required the landfill to shut down at 10:00 a.m. on Tuesday. They are still waiting on the state inspection. The pickup ordered in December for this year finally got here.

Travis Belden – Sheriff – indicated that they are just busy and the jail is close to full.

Heather Morris – Ambulance – shared that there have been a lot of moving missing pieces during her transition. The Responders Policy Manual has been upgraded, which includes the run pay schedule. She is in the process of getting the DEA reinstated to allow controlled medications to be stocked for ALS ambulance transfers; they are working on a plan in the meantime. Reserves are increasing with more individuals picking up applications.

Abbey Mullis – **Assessor** – reported that the Road map was sent to the be digitized to become a layer to the county online maps; she will share when it is available. House sales are really up; Mean sales price is \$189,380 and there are still eight months left in the data gathering period. They don't know if the sale prices will continue to trend up.

Valerie Boyd – Public Health – indicated that they have started flu clinics. The drive through clinic on Saturday provided 244 vaccinations. They appreciated Della's help with the clinic. The county clinics started in Flagler today and will work back to Burlington. The dates for the county employees will be shared.

Kristi Janousek – Human Services – shared upcoming activities that DHS will be involved with including: Trunk and Treat and providing TANF Christmas gifts for those in need. There will be clothes and a gift for the children. They are still looking for an Eligibility Tech. At the end of this year, it looks like the COVID-19 programs may be going away. They are working on an education piece to prepare clients on how these are going away including qualifications for Medicaid and EBT assistance. The current paperwork indicates that there will be a lot of reevaluations in December. Food assistance is already starting to have complaints when the Federal assistance money is late.

Lynsay Cormack – Admin – had reminders for the Department Heads. Cory Stark will be at the Department Head meeting in November to present an hour long emergency exercise. Draft Budget will be approved today and any changes will be needed by December 1st. Employees Annual Evaluations are due to her office by November 1st. Personnel files are required to be in HR that include applications, certificates, write ups, etc. If someone inquires about an employees' files, they should be directed to contact HR. **Cory Wall – Commissioner District 2** – shared that it is a good time to have a skeleton crew in District 2 since it is super dry and not as much to do. They are using time off helping with harvest.

Stan Hitchcock – Commissioner District 1 – reported the same with the dry conditions but they are still mowing in District 1. The road grader part is still needed with no sign of when it will be found.

Dave Hornung – Commissioner District 3 – indicated that District 3 is done mowing. They are looking at one project this fall of taking out a bridge and replace it with culverts. The county has two big projects with a new show building at the fair grounds and a road south of Stratton. The budget looks good with assessments up between 12-13 million. One area of concern is the issue of retaining employees; the county will have to stay competitive.

Susan Corliss – Clerk and Recorder – reported that the ballots for the 2021 Coordinated Election have been mailed. Registered voters that have a phone number or email in their registration have been added to BallotTrax, which will send messages when the ballots are mailed, returned, and counted. All registered voters will receive a ballot because of three State measures plus there are school board races in the Arriba-Flagler and Stratton school districts. The staff really appreciated the help from El Paso County when they sent Elijah Shockney to work Motor Vehicles and help catch up the back log while they were short staffed.

The Kit Carson County Department Head Meeting adjourned at 9:05 AM.

Next meeting is Wednesday, November 10, 2021, with Valerie Boyd – Public Health & Environment Director as host.

Director Valerie Boyd is planning on moving Daylene Colglazier to Chronic Health and wants to advertise for a new hire for the CTC program as a 90% FTE. There may be some shifting in the nursing programs as well.

SEP CONTRACT

The purpose of the Single Entry Point (SEP) Agency Option Amendment #2 is to serve as a SEP agency. This amendment is to add training requirements for the new assessment and support plan within the Care and Case Management Information Technology System (CCM), add requirement for a Continuous Quality Improvement Plan, and to modify the monitoring requirements.

This is not something that our IT can do as well as businesses that are set up for that. The Board of County Commissioners discussed that this should be used to cover all of the social media county accounts. Lynsay will get the information together for all of the accounts to be added to the contract. Updates were given on Cheyenne County and the District Attorney. On April 1, 2022, the 48 hour advisement of inmates will go into effect; WebX will be used in the Jail when needed to hold hearings with the magistrate.

GROUNDS & BUILDINGS

Collin Koop gave updates on the bids for a new generator for the Annex. They will get ready for the State to replace the generator at the Bethune Tower by mowing and having the skid steer available to move the generators. It will cost about \$715 to replace the ceiling tiles in the grandstand church booths. Greeley Lock & Key did a walkthrough of the Annex to prepare for the new key cards system for the building. The file room for DHS has been moved to make more room in the visitation room; there will be some upgrades needed to finish the project. Collin would like to advertise for a full time maintenance person because of the projects coming up. Scott Stinnett has 4-Hers lined up to tear down the goat pens and show arena. They will be tagged and put on pallets to store until the show building is finished.

ZOLI VALDJA CONTRACT FOR FAIR

The Board of County Commissioners reviewed a three year agreement with Zoli Vajda, Television Productions LLC (ZTV LLC) for video production services during the Kit Carson County Pro Rodeos in 2022, 2023, and 2024. The crew will consist of the director, two cameraman, one graphic operator, and one replay operator. Kit Carson County is required to provide logos and commercials delivered to ZVTV, LLC, sturdy camera platforms built to specifications, security at the site, crew and parking passes, suitable hotel rooms for each crew member. The payment of \$10,945 per year will be paid as follows: 50% before May 29 each year and balance due at the end of the events final performance.

Cory Wall moved to sign the three year contract with Zoli Vajda, Television Productions LLC for the Kit Carson County Pro Rodeo video production services for at a cost of \$10,000 each year in 2022, 2023, and 2024 from the County General Fund Department 036, seconded by Stan Hitchcock. NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF KIT CARSON COUNTY the Kit Carson County Ambulance Service Responder Policy Manual including the following KCCAS All Staff Compensation be adopted beginning October 13, 2021:

<u>Call pay</u> – Call pay will be paid out per calendar month. Call pay will be based on the schedules that are in the KCCAS ambulance shed office on the bulletin board. If you cover for somebody, you need to let the KCCAS director know in some traceable form of such coverage.

Day Shift is considered: Burlington and Stratton sheds 6am to 6pm Night Shift is considered: Burlington and Stratton sheds 6pm to 6am

Weekday and Weeknight Coverage: The following table applies for coverage Monday morning day shift at 6am through Friday day shift ending at 6pm:

First Responder	\$1.00 per hour	EMT-Intermediate	\$1.35 per hour

Weekend and Holiday coverage: Crew members that cover a consecutive 24-hour period will be paid \$50 for on-call pay, plus get run pay. Weekend coverage is defined as Friday night shift starting at 6pm through Sunday night shift that ends on Monday mornings at 6am. If you cover Friday night through Monday morning (the entire weekend) your weekend pay will be \$125.00 for call.

Major holidays are: New Year's Eve, New Year's Day, Easter, Memorial Day, Independence Day, Labor Day, Thanksgiving, Christmas Eve, and Christmas Day.
